APCPL/IGSTPP reserves the right to allocate fly ash on free of charge basis as may be allowed under the Law and as defined in the 'Terms & Conditions' applicable for this EOI. The Issue of fly ash may be made free of charge to eligible manufacturers as defined by MoEF's Gazette Notification dated 03.11.2009 read with latest amendment, if any.

In case demand (as assessed by APCPL from the documents of the respective agencies) for free Issue of fly ash exceeds the supply to be made under the law, the allocation of quantity of such fly ash may be done on pro-rata basis at the sole discretion of APCPL/IGSTPP. APCPL/IGSTPP may enlist/empanel interested parties for issue of dry ESP fly ash. The fly ash allotted by APCPL for a particular manufacturing facility of the agency is non-transferable for any other unit/manufacturing location.
