Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned

Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

ATC RULE OF THIS TENDER

" "The bidder should have experience of minimum two years in successfully executing the solid waste management works/Organic Manure manufacturi ng or bio-waste processing works issued by Municipal corporation/state go vernment/central government/PSUs during last seven (07) years as on the date of techno-commercial bid opening. The bidder shall submit the client c ertificate for experience which shall include the nature of work done, the va lue of work, date of

start, date of completion as per order and actual date of completion and sat isfactory completion of service"..."

Any bidder who has been under any banning/suspension/withholding/in eli gible to participate with NTPC Ltd/APCPL as on Bid Opening Date shall be o ut rightly rejected & their offer shall not be considered for evaluation.

ii) Not withstanding anything stated above, the owner reserves the right to assess the bidder's capability and capacity to perform the contract, should the circumstances warrant such assessment in the overall interest of APCPL Ltd and decision of APCPL in this regard shall be final.

iii) APCPL reserves the right to accept or reject any or all tenders without assigning any reasons thereof.

In such Circumstances, EMD only (if applicable) shall be returned without any additional financial liabilit y to APCPL If the last date of receiving application and date of bid opening coincides with a holiday, the date will be shifted to the next working day.

- a) Vendor to quote their rate in applicable section on GeM Portal. Price evaluation will be done based on Lu mpsum price quoted by Bidder.
- **b)** Rate/ Amount written anywhere else in Bid Document shall not be considered and will be treated as Null and Void.
- c) The bidder has to quote Total Contract Price (Inclusive of all taxes & duties, including the applicable GST o n Lumpsum Basis on GeM portal).
- d) By default, the total quoted value of bidder shall be considered as inclusive of GST @ 18%.
- e) In case the Quoted GST is different from 18%, Bidder has to mention in the Annexure-13 the rate of GST (%) as applicable seven (7) days prior to last date of Bid Submission; considered to be inclusive in the Tota I Contract Price on lumpsum basis quoted in GeM portal.
- f) Quantity Mentioned "1" in Gem Bid for each item represents Lumpsum-price {i.e. {Quantity x Unit Rate} + Quoted GST) for individual line item.
- **g)** In case of any discrepancy between the Lump Sum quoted price on the portal and uploaded Price breaku p by the bidder, the Lump Sum price will prevail. Buyer can ask for the revised breakup from service provi

der offline.

- **h)** All the bidders will have to upload the PDF of the filled price breakup in the given format while participati ng in the bid. This shall be a Mandatory upload.
- i) L-1 evaluation will be done on the basis of the Lumpsum price quoted by the bidder and price breakup wil I not have any impact on the L-1 discovery.

j) The Breakup of BOQ or price Breakup should be uploaded under financial cover only (Financial

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
